



## STENGTHENING DIALOGUE

### SETTING A GOAL

Within the project, we strive to develop and strengthen dialogue and coordination among different institutions, including civil society and the private sector.

We seek to create an instance for urban integrated planning of Asuncion's metropolitan area, involving all key stakeholders like the municipalities and central government institutions.







### INTEGRAL METROPOLITAN APPROACH

### A COMMON GROUND

The concept of an Autonomous Institute for Planning of Asuncion's Metropolitan Area (IAPAMA), was initially conceived as a high-level technical body with competencies in urban planning, institutional development, capacity building and development policies. The mandate would be to lead interinstitutional and intersectoral coordination in Asuncion's Metropolitan Area and facilitate the implementation of each of the eleven cities' Sustainable Development Plan (PDS).

### INTEREST AND PARTICIPATION

### **REACHING A CONSENSUS**

There was an initial agreement regarding the need to create the space for coordination, planning and monitoring of investments in infrastructure projects that would take place in Asuncion's Metropolitan Area (AMA).

In order to continue in this direction, key stakeholders signed a Letter of Intent, seeking to stregthen the process started by the Project and created a roadmap to consolidate the idea of establishing the IAPAMA.

This represents a major paradigm shift in municipal and central government management.

The proposal is to benefit from one of the Project's existing working groups, which already includes all key stakeholders, and scale up towards a new methodology of a Dialogue Platform. The latter will be a space for coordination, planning and monitoring of projects to be implemented in the AMA.

Furthermore, this allows to continue to build trust among key stakeholders and provides the opportunity to discuss all issues prioritized by each of them.










